

## **New Parking Implements**

- Residents will be issued <u>resident</u> parking sticker by Res Life to place on right side of their vehicle along with purchasing parking permit.
- We have increased our grace period for when citations fines are doubled to 90 days.
- We have increased the appeal days for any Citation. You must appeal within <u>25 days</u> of receiving the citation.
